## SECONDARY SCHOOL-AGE NASAL FLU VACCINATION

The School-Age Immunisation Service is delivering the flu immunisation programme in Cornwall's and Devon's schools on behalf of NHS England & Improvement. Flu can be a very unpleasant illness and sometimes causes serious complications. Vaccinating your child will also help protect more vulnerable friends and family by preventing the spread of flu.

In 2023/24 all students in secondary schools in Years 7 – 11 will be offered the vaccine. The vaccination is free and recommended for children and young people; it is administered by a quick and simple spray up the nose. Please submit your consent **by midday on 30<sup>th</sup> November 2023** to ensure your child receives their vaccination. If you experience any problems accessing the form please **telephone 01872 221105 for Cornwall schools** and **01392 342678** for Devon schools, and the team will be happy to help. Please note that as in previous years **you must opt in** to the programme. If a consent form is not submitted your child might not be vaccinated.

 Important: Your child can self-consent to treatment if they are considered competent to do so by one of our nurses; this is known as Gillick competency.
